

PUBLIC FIRE PROTECTION

AVAILABLE:

To the Towns of Orono and Veazie for Municipal Fire Protection

RATE:

The rate for existing (238) hydrants as installed on the system at September 8, 2023,
shall have an annual charge of

\$ 547,753 Annually

Orono (168) \$ 386,649

Veazie (73) \$ 161,104

Rate for hydrants installed after October 11, 2022, shall be determined
in accordance with the Public Utilities Commission Rules and Regulations
Chapter 69.

The hydrant rental charge shall not be reduced, should a Town order
one or more hydrants discontinued.

TERMS OF PAYMENT:

Charges under these rates will be billed and payable quarterly in
advance, at the option of the District. All bills shall be due and payable upon presentation.


Unpaid balances of accounts thirty (30) days or more past due will be charged interest

PRIVATE FIRE PROTECTION

AVAILABLE:

To customers using the District's service for private fire protection the following rates apply to fire protection only and include no allowance of water for other than fire fighting purposes.

RATES:

For each fire hydrant installed on owner's premises \$ 1,026

For each service main entering a building for the supply of standpipes, or sprinklers, an annual charge according to the diameter of the service is as follows:


For each four inch service	\$ 494
For each six inch service	\$ 890
For each eight inch service	\$ 1,185
For each ten inch service	\$ 1,482
For each twelve inch service	\$ 1,779

TERMS OF PAYMENT:

Charges under these rates shall be billed and payable quarterly in advance, at the option of the District. All bills shall be due and payable upon presentation.

Unpaid balances of accounts thirty (30) days or more past due will be charged interest at the rate set annually by the Public Utilities Commission of the State of Maine
