 - Plant is producing good water. Battle with green sand. More anthracite for two filters. May be manganese and may not be backwashing enough.
 - Orono Student Union 31.3THHM and 14 HAA5
 - Veazie State Street 64.4THHM and 0HAA5 (may due to well 3 redevelopment and Kelly Road standpipe was off line.)
 - Wells 1-3 wells were redeveloped
 - Well 1 and 2 back and can get another year out of them.
 - Well 3 did not come back as well as last year.
 - Quote from Scott Kelly and Mike Judkins for redevelopment under pressure with Aquafreed and additional cleaning under pressure.
 - May have to redevelop two wells and may have to purchase water from Old Town while working.
 - Chemo Pond Dam water level issues
 - President of Chemo Pond Organization
 - Chemo Pond Dam owned by OVWD
 - Need to acquire ownership paperwork.
